



# VELUX Architecture Competition 2024/25

## Competition

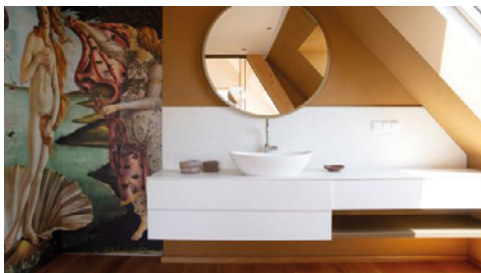
### 1. Awarding authority and objective of the VELUX Architecture Competition 2024/25

In 2024, the roof window manufacturer VELUX (“VELUX” or “awarding authority”) announced the second **Architecture Competition Light.Space.Human** for Germany, Austria and Switzerland. Architects, interior designers, and planners are invited to present to a distinguished jury their ideas and solutions to add more daylight, air and spatial quality.

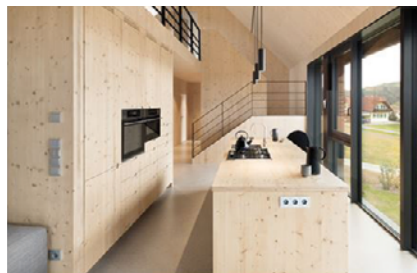
From **1 June 2024** all building projects in which **light, space and humans** play a central role in the design can be submitted.

A **convincing daylight concept** is required, among other things, through the use of **VELUX lighting solutions** such as roof windows, roof window combinations or flat-roof windows.

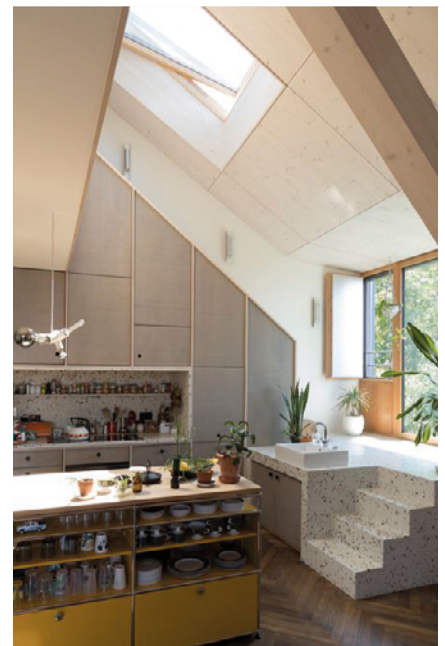

## 2. Competition procedure

The submission of completed projects will take place online from **1 June 2024 to 28 February 2025** at [www.velux.de/architektur/aw2025](http://www.velux.de/architektur/aw2025). After the preliminary examination for completeness as well as formal and substantive correctness conducted by the architecture trade magazine DETAIL Business Information GmbH, a pre-jury consisting of DETAIL and VELUX will select a maximum of 50 works..

These submitted works will be presented to a qualified expert jury consisting of renowned architects and media representatives. The jury will nominate up to seven projects (shortlist) from which it will select three prize winners.

## 3. Eligibility

For the VELUX Architecture Competition 2024/25, completed buildings and construction projects located in **Germany, Austria and Switzerland** are eligible, provided they were completed **after 31 May 2021 and before 31 December 2024** and products from VELUX (roof windows, roof window combinations, or flat roof windows) are part of the daylight concept.

Architects, civil engineers and interior designers, who are authorised to use their respective professional titles are eligible to participate. In case of consortiums, at least one member must provide proof of eligibility. Participation is possible with a maximum of three projects. It is required that the participants are in possession of the unrestricted copyright from the submitted buildings and construction measures.

It is required that the participant clarifies with the builder/current owner that the project will be submitted and may be communicated worldwide as a reference for VELUX in the course of the competition. Jury members, their offices, partner offices and employees of VELUX and DETAIL are excluded from participation. Projects that have already been nominated in any of the previous awards (i.e. mentioned in the shortlist) are also excluded.

The application documents must be submitted on time and in full and must comply with the specified formal and content-related criteria in all respects.

## 4. Competition services

### 4.1. Language and submissions

The **competition languages are German and English**. Participation is exclusively possible online via [www.velux.de/architektur/aw2025](http://www.velux.de/architektur/aw2025). The project data must be entered in the entry form provided. The requested application documents shall be submitted via upload. Once the project has been successfully submitted, the data entered and documents submitted can no longer be changed. Image and file uploads are automatically checked for size and resolution (see 4.2).

## 4.2. Documents to be submitted

The scope of services includes the **project sheet**, a separate **explanatory report**, and the **declarations of consent** from architects/participants and photographers (“application document”). All documents should include relevant information such as the project titles and the office name and should be saved as follows:

**“Project-Title-Location-Office Name-File Name”** (Project sheet; explanatory report, declaration of consent”).

### 4.2.1. Project sheet

The project sheet, freely designed by the participants, is a DIN A2-landscape format (300 dpi, file size max. 12 MB, .PDF). It should be a comprehensive presentation of the submitted projects, including at least one visual documentation of the installed VELUX product(s).

Plan drawings, sketches and drawings, professionally produced photos, and texts must provide a comprehensive insight into the daylight concept, design, function, chosen materials, and architectural quality of the project. Special focus must be placed on presenting and illustrating the daylight concept and the light atmosphere of the interior. Therefore, representative and professionally taken interior photographs are essential.

In addition, exterior views and concept sketches help make the project comprehensible in its entirety. (Construction site photos are not sufficient here).

The most important drawings such as floor plans, cross sections and site plans are also expected for understanding the project. Depending on the project submitted, the drawings may be presented at scales of 1:500 to 1:1. They should include measurements and be labelled. Good self-promotion is emphasised in terms of graphical representation.

### 4.2.2. Explanatory report

The separate explanatory report is limited to one DIN A4 sheet (max. 3 MB, PDF) per project.

The explanatory report should contain all essential information required to understand the project.

In addition to explaining the design, there should also be a special focus on the **daylight concept**.

## 4.2.3. Declaration of consent: Author, owner, photographer

By participating in the VELUX Architecture Competition 2024/25, the architects/participants accept these tender documents as conditions of participation. Furthermore, declarations of consent from participants and photographers must be provided as a signed electronic document (PDF scan).

- The **architects/participants** declare with their consent that they are eligible to participate and are the intellectual authors of the submitted buildings and the construction projects.

In addition, the participant grants the awarding authority the right, unlimited by time and space, to use the application documents and the photographic or video materials produced showing the buildings and construction measures in connection with the VELUX Architecture Competition for all known editorial purposes, with the names of the respective participants provided. This includes, for example, integration in print materials, display at VELUX websites, use in VELUX social media channels, advertising for the next VELUX competition and dissemination to media (including DETAIL, etc.) for publication in an editorial context (offline/online).

Any use beyond this scope, for example for extended publications or commercial purposes (product advertisement, etc.), is not covered by this statement of consent and will be agreed separately with the participant if required.

The awarding authority is entitled to pass on the right of use within the VELUX Group (VELUX A/S and all affiliated companies within the meaning of § 15 of the German Stock Corporation Act). No remuneration is owed for the granting of the right of use.

By participating, it is assured that the application documents or the submitted buildings and construction measures are free of third-party rights that conflict with the right of use and indemnifies the awarding authority against all third-party claims, in particular claims for infringement of copyright and personal rights. This includes, in particular, that participation in the competition was coordinated by the participants with the client or owners of the project. No indemnification shall be granted if the third party's claim results from the awarding authority's use of the works in contravention of the above provisions.



The participant agrees to be contacted by the awarding authority in connection with the VELUX Architectural Competition 2024/25 in writing, by telephone or by email using the contact details provided as part of the application.

- With his/her declaration of consent, the **photographer** declares that he or she is author of the photographic material submitted with the application documents. They grant the awarding authority the unrestricted right, both temporally and spatially, to use the photographic material in connection with the VELUX Architectural Competition for all known editorial purposes, with the names of the respective participants provided. This includes, for example, integration in print materials, display at VELUX websites, use in VELUX social media channels, advertising for the next VELUX competition and dissemination to media (including DETAIL, etc.) for publication in an editorial context (offline/online). Any use beyond this scope, for example for extended publications or commercial purposes (product advertisement, etc.), is not covered by this statement of consent and will be agreed separately with the photographer if required.

The awarding authority is entitled to pass on the rights of use within the VELUX Group (VELUX A/S and all affiliated companies within the meaning of § 15 of the German Stock Corporation Act). No remuneration is owed for the granting of the right of use.

## 5. Jury and evaluation criteria

The evaluation of the works will be carried out by a 5-member independent jury consisting of the following persons:

In addition, deputy jury members will be appointed. The jury will not meet in public. The jury will decide by a simple majority. The jury will justify its decision by a simple vote. The jury's decision is final and cannot be changed. Legal recourse is excluded.

## 6. Prizes and prize money

### 1st Prize | 2nd Prize | 3rd Prize

The three prize winners will receive a total of 12,000 euros in prize money. The distribution of prize money amongst the individual prize winners shall be at the discretion of the jury. The jury reserves the right to award prizes in recognition of special quality.

The award-winning projects will also be featured in renowned trade and public media:

- Communication of the nominated works and award winners via the website of the DETAIL architecture trade magazine
- Documentation of the nominated works and winners in an online documentation
- Editorial mentions in the trade and general press (print and online)

## 8. Announcement and publication

The official announcement of the nominations (shortlist) will be made for all participants after the jury meeting in March of 2025 at [www.velux.de/architektur/aw2025](http://www.velux.de/architektur/aw2025) and [www.detail.de](http://www.detail.de).

The nominated participants will be notified by telephone and email immediately after the jury meeting.

The announcement of competition winners will be made to all nominees in May/June 2025 at an award ceremony and officially from July 2025 at [www.velux.de/architektur/aw2025](http://www.velux.de/architektur/aw2025) and [www.detail.de](http://www.detail.de).

## 9. Documentation

The documentation of the nominated projects/winners will be in the form of an online publication, which will be presented to a wide audience through various channels.

In addition to documentation, selected projects will be published across different media channels by VELUX and DETAIL. Additionally, the projects can also be disseminated via the trade and general press both in print and online.

## 10. Award ceremony

## 11. Exclusion criteria

Works that contradict the conditions of the competition may be excluded.

The documents must be submitted on time and in full. They must comply with the competition condition in all respects, both formally and in terms of content. To assess the daylight quality in the interior and its underlying concept, significant and professionally produced interior photographs, as well as comprehensive documentation of the daylight concept, should be included in the submissions. We must expressly point out that no extensions to the deadline or late submissions are possible. Jury members, their offices and partner offices, as well as employees of VELUX and DETAIL, are excluded from participation in the VELUX Architecture Competition 2024/25.

## 12. Ownership of the application documents and copyright

The application documents become property of the awarding authority. The copyright remains with the participant.
