

Terms & Conditions for the Competition

Tour de France BIB generator

1. Promoter

The Promoter of this competition is VELUX A/S, Ådalsvej 99, 2970 Hørsholm, Denmark, company reg. no. 30003519 (henceforth: “organiser” or “VELUX”). By entering this competition, entrants agree to be bound by these Terms & Conditions.

2. Eligibility

2.1 The competition is open to individuals aged 18 or over at the time of entry.

2.2 Employees of VELUX, its affiliates, and any parties involved in the administration or execution of the competition are not eligible to enter. By entering, participants confirm that they meet the eligibility criteria and are entitled to claim any prize they may win.

2.3 Only one registration per entrant will be accepted. It is strictly forbidden to use multiple registrations to increase the chance of winning.

2.4 The Promoter reserves the right to disqualify any entrant where there are reasonable grounds to believe that:

- 2.4.1 the entry process has been tampered with or manipulated;
- 2.4.2 these Terms & Conditions have been breached;
- 2.4.3 unfair or unethical conduct has occurred; or
- 2.4.4 false or misleading information has been provided.

2.5 If the disqualified entrant has already been drawn as a winner, the Promoter reserves the right to revoke the prize.

2.6 VELUX will not accept registrations by third parties, organised groups or registrations automatically generated by a computer. Incomplete or evidently false registrations will also be disqualified.

2.7 The Promoter accepts no responsibility for entries that are lost, delayed, corrupted, or not received due to technical issues or otherwise.

3. Participation

3.1 To enter the competition, participants must complete and submit the online entry form in full and accurately. Entry is free of charge. The entry form is available at:

3.2 To be eligible, entrants must provide the following information.

Required fields: First name, last name, name on BIB, BIB number.

Questions to be answered:

- If you were planning a home improvement, which project would you most likely consider?
- If you were to add a roof window to your home, which room would you begin with?
- What would be your main reason for adding a roof window?

3.3 The competition is open from [1st July 2026] until [9th August 2026].

4. Prizes, prize notification and provision of the prize

4.1 Among all participants who meet the conditions, the organiser will randomly select the winners of:

6 x Zwift Bikes worth approx. EUR 1,200 each.

6 x Sports Merch Goodie bags worth approx. EUR 105 each.

4.2 Winners will be randomly selected within 4 weeks of the closing date (no later than 7th September 2026). The winners will then be contacted by the Promoter by email.

4.3 Winners must respond to the notification email and provide a valid shipping address in order to claim their prize. If a winner fails to respond within a reasonable period, and after a follow-up reminder has been sent, the Promoter reserves the right to forfeit the prize and select an alternative winner.

4.4 The Promoter will cover the cost of delivery of the prizes. Risk in the prize passes to the winner upon delivery to the specified address. The Promoter is not responsible for loss or damage in transit. Additional costs associated with the use of the prize shall be borne by the winner. The winner is responsible for any taxes or charges of the prize.

4.5 Only one prize per person will be awarded. Prizes are non-transferable, non-exchangeable, and no cash alternative will be offered.

4.6 The Promoter reserves the right to verify the identity and eligibility of any entrant or winner.

5. Data protection

5.1 Personal data (see above in 3.2) is required for participation in the competition. By entering, participants confirm that the information provided is accurate and complete.
